July 9th 2024 Council Meeting called to order @6pm by Mayor Smith Minutes taken by Manager/Recorder Deborah Oatman

1 Open Floor

Public comment from Diane Higbie about her concerns of unbecoming behavior from council members was read. Deborah gave her resignation.

2. Iron Triangle Mill Fire

Mike Allen stated that when the Fire Department got there the whole east side was engulfed in flames and encroaching on farmers property and called John Day dispatch, who is always on standby where the mill is concerned. Mayor Smith stated that Drew was on an excavator when the wind really came up and with in 10 minuets there were flames. Zach Williams stated that the hog pile is always on fire internally. They were able to get rid of material for a while but that has dried up due to too much bark content and have a new de-barker machine going in that will help separate content. They are screening the material that burned and burning the larger material in the air burner and using the material as a berm around the edge and spreading out the rest of the remaining hot material working at keeping it to less than 18 inches deep then rolling it to keep the oxygen out. They are always looking for ways to market the material and have recently tilled sawdust into soil to improve the soils structure on parts of Jack Southworth's properties, have a debarker that will put out different product, would like to put a fire hydrant at the end of the city street that ends at the Southworth's property at their expense, and are willing to do a fire line around the city.

3. Fire Chief Mike Allen

Shared the cost analysis of the last large Iron Triangle fire proposing the city consider billing for some of the cost, which came to just over \$6000, considering that it is a continuous problem.
